ORDER

As per the Government order as read ist paper above, Kollam Municipality and Thrissus Municipality were upgraded as Corporations incorporating neighbouring Grama Panchayats. Even though the above two Municipalities were upgraded as Corporations, no additional posts were sanctioned proportionately. Considering necessity for creation of additional posts for effective functioning of the above two Corporations, Govt. as per GO read as 2nd paper above have appointed Sri Parameswaran Nair, Rtd. Director of Urban Affairs for conducting a study and furnished report to Government. In the study report it has pointed out that additional posts are highly necessary to the newly formed two Corporations, viz., Kollam and Thrissau, for carrying out the developmental and administrative activities effectively and has recommended to create 62 additional posts in Kollam and 63 posts in Thrissur Corporations. After considering the recommendations in the study report, existing staff strength and the posts available in the Development Wing of the above two Corporations consequent on the winding up of Development Authorities, Government have decided to create 48 posts in Kollam and 49 posts in Thrissus Corporations, and are pleased to issue orders creating following posts in Kollam and Thrissur Corporations as detailed below:
