ORDER

As per the Government Order read as first paper above, Government had approved a proposal for establishing Hospital Kiosks in 52 Government Hospitals and 130 Private hospitals in 5 Corporation areas for improving service delivery relating to civil registration in Corporations.

As per the Government Order read as second paper above, Government had issued orders for extending the project to Municipalities and Grama Panchayats.

As per the Government Order read as third paper above the management of Hospital Kiosks established under modernising Government Programme was transferred to the respective local bodies.

The Executive Chairman and Director, Information Kerala Mission in his letter read as fourth paper above has reported to Government that prior to the transfer of programme to the respective local bodies, the service charge collected by Information Kerala Mission from hospitals were remitted in the accounts of respective local Governments. The charge so remitted as detailed in the annexure up to the date of transfer of management ie. 31-07-2008 is to be returned to Information Kerala Mission as

Information Kerala Mission was meeting all the expenditures related to Kiosk in these places and requested Government to direct the local bodies to return the said charge to Information Kerala Mission.

Government have examined the matter in detail and are pleased to order that the local bodies as detailed in the annexure should remit back to Information Kerala Mission the service charges remitted by Information Kerala Mission in the Local Bodies up to the date of transfer of management immediately.


