ORDER

As per the Government Order read 1st above, Government had revised the rate of cost of tender forms issued by Stationery Department with effect from 15-5-1999. As per the Government Order read 2nd above, these rates were made applicable to all other Government Departments.

2. It came to the notice of the Government that in spite of the manifold increase in the cost of works and supplies since 1999, the cost of the tender forms had not been revised.

3. Government have examined the matter in detail and are pleased to revise the existing rates of cost of tender forms issued for the works and supplies of all department as follows with immediate effect.

Works/supplies costing more than Rs. 10 lakhs	0.15% of the cost of the work, rounded to the nearest multiple of 100, subject to a maximum of Rs. 25,000+VAT @ 12.5%	50% of the cost of the original, upper rounded to the nearest multiple of Rs.100+VAT @ 12.5%
