ORDER

- In the Government Order read as 1st paper above, Government have issued revised guidelines for the allocation and drawal of funds to Local Self Government Institutions.
- 2. As per the Government Order read as 4th paper above sanction was accorded for the transfer credit of Rs. 187,08,43,700/- (Rupees One hundred and eighty seven erore eight lakh forty three thousand seven hundred only) from the Consolidated Fund under Major Head of Account, '3604 Compensation and Assignments to Local Bodies and Panchayat Raj Institutions' to the Public Account under Major Head of Account, '8448 Deposits of Local Funds' to release the instalment due for the month of May, 2009 (1st instalment) being the Funds for Expansion and Development to Local Self Government Institutions and for the payment of incentive to award winning LSGIs. Sanction was also accorded for the release of Rs. 183,73,43,700/- (Rupees One hundred and eighty three crore seventy three lakh forty three thousand seven hundred only) being 1/10th of the net allocation carmarked to the Local Self Government Institutions in respect of Funds for Expansion and Development under different sectors as per the distribution in Appendix IV to the Detailed Budget Estimates, 2009-10.
- 3. In the circumstances, Government are pleased to release 1/10th of the current years budget provision allocated to Local Self Government Institutions amounting to Rs. 183,73,43,700/- (Rupees One hundred and eighty three crore seventy three lakh forty three thousand seven hundred only) as 1st installment of Expansion and Development Fund for the month of May, 2009 as per the entitlement envisaged in Appendix IV to the detailed Budget Estimates 2009-10.
- 4. The Director of Panchayats will allot the net amount (excluding the deducted amount from 2009-10 allocation) set apart for each Grama Panchayat to their Secretaries of Grama Panchayats directly as stipulated in the Government Order read as 2nd paper above.

- 5. The Commissioner for Rural Development will allot the net amount (excluding the deducted amount from 2009-10 allocation) set apart for each Block Panchayat to the Secretaries of Block Panchayts directly adhering to the conditions stipulated in the Government Order read as 2nd paper above.
- 6. The Director of Urban Affairs will allot the net amount (excluding the deducted amount from 2009-10 allocation) set apart for each Municipality to the Secretaries of the Municipalities directly subject to the conditions laid down in Government Order read as 2nd paper above.
- Government are also pleased to allot the following amounts as the 1st instalment of the Development fund to the 14 District Panehayats and 5 Corporations as shown below.
