Commissioner for Rural Development has also requested to issue order for meeting the expenses for the training of teachers at Block level initially from the funds available at PAUs and at Municipal/Corporation level from the own funds of Municipalities and corporations, which will be recouped on receipt of funds from the State Government.

Government have examined the matter in detail and are pleased to approve the cost ceiling for incurring expenditure at Block/Municipal/Corporation level for conducting training of teachers deployed as investigators for BPL survey, for a batch of 100 persons as proposed by Commissioner for Rural Development for a total cost of Rs.13,700/-

Sanction is also accorded for meeting the expenses for the training of teachers at Block level initially from the funds available at PAUs and at Municipal/Corporation level from the own funds of Municipalities and corporations subject to the condition that the same will be recouped on receipt of funds from State Government.
