### ORDER

- As per the Government Order read as 1st paper above, Government have issued revised guidelines for the allocation and drawal of funds to Local Self Government Institutions.
- As per Government Order read as 3rd, 4th and 5th paper above sunction was accorded for the release of 1st, 2nd and 3rd installment for the month of April, May and June, 2009.
- 3. Now as per the Government Order read as 6th paper above, an amount of Rs. 42,80,44,000/- (Rupees Forty Two crore Eighty lakhs and Forty Four thousand only) was transfer credited from the Consolidated Fund under Major Head of Account, '3054 -Roads and Bridges' and '3604 Compensation and Assignments to Local Bodies and Panchayat Raj Institutions' to the Public Account under Major Head of Account, '8448 Deposits of Local Funds' as 4th installment for July, 2009 and also sanctioned for its release. Accordingly sanction is accorded for the release of Rs.25,39,89,400/- (Rupees Twenty Five crore Thirty Nine lakh Eighty Nine thousand and Four hundred only) for Maintenance Expenditure of Non-Road Assets and Rs.17,40,54,600/- (Rupees Seventeen crore Forty lakh Fifty Four thousand and six hundred only) for maintenance expenditure of Road Assets from the funds so transfer credited being 1/10<sup>th</sup> of allocation earmarked to the Local Self Government Institutions as 3rd installment for the month of July, 2009.
- 4. The distribution of funds among the Local Self Government Institutions is based on the statement appended to the Government Order read as 6th paper above. The amount so transfer credited is exempted from treasury restrictions.
- 5. The Director of Panchayats will release the 4th installment of the 1/10<sup>th</sup> of the maintenance expenditure (Road Assets & Non Road Assets) earmarked to the Grama Panchayats. The Director of Urban Affairs will release the 4th installment of the 1/10<sup>th</sup> of the maintenance expenditure (Road Assets & Non Road Assets) earmarked to the Municipalities. The Commissioner for Rural Development will release the 4th installment of the V10<sup>th</sup> of the Maintenance Expenditure (Non Road Assets) to the Block Panchayats in accordance with the guidelines prescribed in para 3 of the Government Order rend as 1<sup>st</sup> paper above.
- Government are also pleased to release the following amounts as the 4th installment of maintenance fund to the District Panchayats and the corporations as follows:
