#### ORDER

- 1. As per the Government Order read as 1st paper above, Government have issued revised guidelines for the allocation and drawal of funds to Local Self Government Institutions.
- 2. As per Government Order read as 3rd, 4th, 5th, 6th, 7th, 9th, 11th and 12th papers above sanction was accorded for the release of 1st, 2nd, 3rd, 4th, 5th, 6th, 7th and 8th installment for the month of April, May, June, July, August September, October and November 2009.
- 3. Now as per the Government Order read as 13th paper above, an amount of Rs. 42,80,44,000/- (Rupees Forty Two crore Eighty lakhs and Forty Four thousand only) was transfer credited from the Consolidated Fund under Major Head of Account, '3054 -Roads and Bridges' and '3604 - Compensation and Assignments to Local Bodies and Panchayat Raj Institutions' to the Public Account under Major Head of Account, '8448 - Deposits of Local Funds' as 9th installment for December, 2009 and also sanctioned for its release. Accordingly sanction is accorded for the release of Rs.25,39,89,400/- (Rupees Twenty Five crore Thirty Nine lakh Eighty Nine thousand and Four hundred only) for Maintenance Expenditure of Non-Road Assets and Rs.17,40,54,600/- (Rupees Seventeen crore Forty lakh Fifty Four thousand, and six hundred only) for maintenance expenditure of Road Assets from the funds so transfer credited being 1/10th of allocation earmarked to the Local Self Government Institutions as 9th installment for the month of December, 2009.
- 4. The distribution of funds among the Local Self Government Institutions is based on the statement appended to the Government Order read as 13th paper above. The amount so transfer credited is exempted from treasury restrictions.
- 5. The Director of Panchayats will release the 9th installment of the 1/10th of the maintenance expenditure (Road Assets & Non Road Assets) earmarked to the Grama Panchayats. The Director of Urban Affairs will release the 9th installment of the 1/10th of the maintenance expenditure (Road Assets & Non Road Assets) earmarked to the The Commissioner for Rural Development will release the 9th installment of the 1/10th of the Maintenance Expenditure (Non Road Assets) to the Block Panchayats in accordance with the guidelines prescribed in para 3 of the Government Order read as 1st paper above.

6. The required amount to meet the expenditure on maintenance of roads constructed under PMGSY Scheme is also deducted from the 9<sup>th</sup> installment of District Panchayats concerned as ordered in the Government Order read as 8th paper above. An amount of Rs. 62,54,308/- due to Kerala Water Authority in respect of Kollam Corporation will be deducted from 9th and 10th installment of maintenance grant (Non-roads) in two equal installment of Rs. 31,27,154/- each as ordered in Government Order read as 10th paper above. Accordingly, Government are pleased to release the following amounts as the 9<sup>th</sup> installment of maintenance fund to the District Panchayats and the corporations as follows:
