ORDER

Accordingly Government as per the Order read as 2nd paper above have sanctioned additional funds to the tune of Rs. 20,00,00,000/- (Rupees Twenty Crore Only) over and above the current financial year's allocation under Funds for Maintenance Expenditure (Road Assets) to 14 District Panchayats for meeting the additional commitment in respect of Maintenance Works of Roads handed over by Government.
