ORDER

- 1. As per the Government Order read as 1st paper above, Government have issued revised guidelines for the allocation and drawal of funds to Local Self Government Institutions.
- 2. As per the Government Order read as 3rd paper above, an amount of Rs. 44,05,79,500/- (Rupees Forty Four crore Five lakhs Seventy Nine thousand and Five hundred only) was transfer credited from the Consolidated Fund under Major Head of Account, '3054 -Roads and Bridges' and '3604 Compensation and Assignments to Local Bodies and Panchayat Raj Institutions' to the Public Account under Major Head of Account, '8448 Deposits of Local Funds' as 1st installment for April 2010 and also sanctioned for its release. Accordingly sanction is accorded for the release of Rs.24,76,35,100/- (Rupees Twenty Four crore Seventy Six lakh Thirty Five thousand and One hundred only) for Maintenance Expenditure of Non-Road Assets and Rs.19,29.44.400/- (Rupees Nineteen crore Twenty Nine lakhs Fourty Four thousand and Four hundred only) for maintenance expenditure of Road Assets from the funds so transfer credited being 1/10th of allocation earmarked to the Local Self Government Institutions as 1st installment for the month of April, 2010.
- 3. The distribution of funds among the Local Self Government Institutions is based on the statement appended to the Government Order read as 3rd paper above. The amount so transfer credited is exempted from treasury restrictions.
- 4. The Director of Panchayats will release the 1st installment of the 1/10th of the maintenance expenditure (Road Assets & Non Road Assets) earmarked to the Grama Panchayats. The Director of Urban Affairs will release the 1st installment of the 1/10th of the maintenance expenditure (Road Assets & Non Road Assets) earmarked to the Municipalities. The Commissioner for Rural Development will release the 1st installment of the 1/10th of the Maintenance Expenditure (Non Road Assets) to the Block Panchayats in accordance with the guidelines prescribed in para 3 of the Government Order read as 1st paper above.
- 5. Out of Rs. 46,20,000/- ordered to be deducted from the Maintenance Fund (Road Assets) of Malappuram District Panchayat for the maintenance of PMGSY Roads, Rs. 34,43,000/- was deducted during the last financial year. As such balance amount of Rs. 11,77,000/- will be deducted from the Road Fund allocated to Malappuram District Panchayat during this Financial Year. Commissioner for Rural Development will draw and remit the deducted amount to KSRRDA as ordered in the Government Order read as 2nd paper above.
