ORDER

The Commissionerate for Rural Development was set up with effect from 1.02.1987 as per G.O read above for the effective implementation and supervision of Rural Development Programmes of the State Government. Secretariat Staff were deployed in the Commissionerate of Rural Development for the smooth functioning of the Office. At the time of formation of Commissionerate of Rural Development six sections in the Rural Development Department in the Administrative Secretariat were shifted to the Commissionerate, and it was ordered in the Government Order that the posts transferred to the Commissionerate of Rural Development from Administrative Secretariat will also be reckoned for the purpose of fixing cadre strength in the Administrative Secretariat. Hence the cadre strength of Officers, Assistants, Typists, Confidential Assistants and Peons in the Administrative Secretariat were fixed accordingly. As per the above Government Order a separate Ministerial Service will be formed in the RDD in due course by inviting options from personnel of the Revenue Department working in the Development Sections in the Collectorates and Block Development Offices.

Although, a separate Ministerial Service was subsequently formed for the Rural Development Wing (now part of the LSGD) and the Ministerial Staff in the Offices in the Rural Development Wing, except for certain posts in the Commissionerate which belong to that service, bulk of the Ministerial Staff in the Commissionerate continued to be drawn from the Secretariat. That system continues till today. The Commissioner for Rural Development has submitted a proposal as per reference cited for recognizing the commissionerate staff structure.

Government have decided that since a separate Ministerial Service is formed and there are sufficient staff with adequate experience available, it is high time to deploy them in the posts in the Commissionerate, except for the posts earmarked for the Secretariat Staff i.e., Senior Administrative Officer and Senior Finance Officer and the posts of Accounts Officer and the Internal Audit Officer. This transition may be effected in a phased manner. In the 1st phase the posts upto and including the Section Officer may be considered for redeployment. The question of posting of staff from the Ministerial Service to the posts of Accounts Officer and Internal Audit Officer may be considered in 2nd phase.

Government have examined the case in detail and are pleased to issue the following orders :

- 1) The non gazetted Posts of Secretariat now functioning in the Commissionerate for Rural Development are shifted to the Secretariat to be adjusted in the retirement / arising vacancies w.e.f.31.03.2010
- 2) The Gazetted Posts of Secretariat except Senior Administrative Officer and Senior Finance Officer now functioning in the Commissionerate for Rural Development are shifted to Secretariat to be adjusted against the retirement vacancies w.e.f 31.03.2010.
- 3) The following ministerial posts are created in Commissionerate for Rural Development for substituting the ministerial staff being reverted to the Secretariat.
