ORDER

As per Order read above, Government have re-organised the Block Panchayats in the State, inter alia creating 6(six) new Block Panchayats, namely Kalikavu, Panamaram, Kallyasseri, Panoor, Parappa and Karadukka with effect from the 1st of October 2010.

2) As per paper read as 2nd above, the Commissioner for Rural Development submitted a proposal for the appointment of Special Officers in the newly formed Block Panchayats, for the purpose of finding office buildings and for providing basic infrastructural facilities for the six Block Panchayats.

3) Government have examined the matter in detail and are pleased to appoint Officers on Special Duty as follows for each of the newly constituted Block Panchayat noted against their name.

Sl. No.	Name of Block Panchayat	Officer on Special Duty
1	Kalikavu	Assistant Development Commissioner (G1), Malappuram
2	Panamaram	Assistant Development Commissioner (G1), Wayanad
3	Kallyasseri	Assistant Development Commissioner (G1), Kannur
4	Panoor	Project Director, Poverty Alleviation Unit, Kannur
5	Parappa	Assistant Development Commissioner (G1), Kasargod
6	Karadukka	Project Director, Poverty Alleviation Unit, Kasargod

4) The Officers on Special Duty are entrusted with-

a) To find out suitable office buildings on rent, for accommodating the newly constituted Block Panchayats, in the places which are notified as the Headquarters of the Block Panchayats itself, as far as possible.

- b) To take suitable steps to procure/provide minimum required infrastructural facilities for these offices so that these offices can start functioning in a full fledged manner w.e.f. 01-11-2010, the date on which the newly elected committees are to take office, after the General Election.


