## <u>CIRCULAR</u>

Sub:- LSGD - Action on 15<sup>th</sup> para of the recommendation of 91<sup>st</sup> Report of the Public Accounts Committee (2014-15) - Reg.

Ref:- Letter No.15419/PAC-A2/2014/Leg. Dated 10.07.2015 of Secretary, Kerala Legislature Secretariat, Thiruvananthapuram.

Kerala Legislature Secretariat, Kerala Legislature Assembly had furnished the 91<sup>st</sup> Report of Public Accounts Committee (2014-15) to Government for strict compliance. The Public Accounts Committee pointed out that the very act of Paramedical Council in having drawn money from the treasury and deposited it in a Saving Bank Account of a Nationalised Bank is highly irregular. This tantamount to monetary manipulation and malpractice. As per the 15<sup>th</sup> para of the report, the Committee moots that administration department should take conscientious efforts to avoid such fund transactions. It recommends that disciplinary action should be initiated against the officials responsible for it in case of such irregularity and they should be levied with penal interest @ 18% of the fund so transferred.

In the light of the recommendation in the 15<sup>th</sup> para of the report, it is hereby directed that all Heads of departments/heads of institutions under Local Self Government Department should avoid such fund transactions and should take disciplinary action against the officials responsible for it in case of such irregularity and they should be levied with penal interest @ 18% of the fund so transferred.
