## **CIRCULAR**

Sub: LSGD - Mapping of Central Schemes with PFMS - reg.

As per the Government of India guidelines, all funds under the Centrally Sponsored Schemes are to be channelised through Public Financial Management System(PFMS) only from the Ministry level up to the last level agencies of the States, failing which Central Ministry may opt to suspend further funding for the scheme.

Ministry of Panchayath Raj informed that CFC grants and grants under other schemes of MoPR shall not be released in case integration and mapping of unique agency code is not completed before 1<sup>st</sup> April 2021.

Ministry of Housing and Urban Affairs also insisted that linking the ULB accounts for 15<sup>th</sup> Finance Commission grants with PFMS should be completed by 31<sup>st</sup> March 2021.

As per the minutes of the meeting 1<sup>st</sup> cited, it was decided that Panchayats' are to be registered with PFMS by 20<sup>th</sup> March 2021. As per the Government order 2<sup>nd</sup> cited, general sanction has been accorded to LSGI's to open Bank Account to receive and operate 15<sup>th</sup> Finance Commission grants through PFMS platform. Hence all Local Self Government Institutions are hereby instructed to complete the registration with PFMS by 20<sup>th</sup> March 2021.

As per the Government order 3<sup>rd</sup> cited, guidelines have been issued to modify the present system of withdrawal of Finance Commission grants. Therefore, all LSG Institutions are instructed to comply the modified system of withdrawal of FFC grants.

As per the Government order 4<sup>th</sup> cited, general permission has been accorded to all Heads of Departments to open Bank Accounts for registering Centrally Sponsored Schemes in PFMS Portal. Hence all Head of Departments are hereby directed to complete the mapping of Central Schemes with PFMS on or before 1<sup>st</sup> April 2021.
