## **ORDER**

The time limit for crediting arrears of DA to the PF Account of the employees allowed as per G.O. read 1<sup>st</sup> paper above, expired on 31.08.2008. Time limit for crediting the DA arrears sanctioned as per G.O.(P) No.120/07/Fin dated 20.03.2007, G.O.(P) No.531/07/Fin dated 05.11.2007, G.O.(P) No.547/07/Fin dated 14.11.2007 and G.O.(P) No.91/08/Fin dated 16.02.2008 have also expired.

Several requests are being received from various institution Heads and individuals seeking extension of time for crediting the arrears of DA to the PF Account.

Government have examined the requests and are pleased to order that the time limit for crediting the arrears of DA sanctioned from 01.01.2005, 01.07.2005, 01.01.2006, 01.07.2006, 01.01.2007 and 01.07.2007 to the PF Account of employees will be extended up to 31.12.2008. The DA arrears will be claimed in the salary bill up to December 2008 and credited to PF Account without fail.

Further extension of time will not be allowed for crediting DA arrears sanctioned with effect from 01.01.2005 and 01.07.2005.
