- The Office of the Grama Panchayats which are to be merged with Municipalities/Corporations will function as the Zonal Office of the concerned Corporations/Municipalities with effect from 01.11.2010 to complete residual work and transfer formalities.
- The Panchayat Staff working in the Panchyats which are to be converted into Municipalities and in the Panchayats that will be merged with Corporations/Municipalities, will be allowed to continue on working arrangement from 1/11/2010 to 31/03/2011.
- The Secretaries of the Panchyats to be converted into Municipalities are allowed to continue as Special Officers acting as Municipal Secretaries from 01.11.2010 till 31/03/2011.

Separate Orders will be issued regarding the posting of Special Grade Secretaries/Secretary of Panchayats merged with Corporation / Municipalities.
