**ORDER**

Government of India have decided to restructure Swarna Jayanti Grameen Swarozgar Yojana (SGSY) into a comprehensive programme focusing on the livelihoods of the poor and the new programme is called the National Livelihood Mission. In order to implement the programme in the State with immediate effect, Government order the following:

- 1) The State Poverty Eradication Mission (Kudumbashree) will be the State level Mission under NRLM.
- 2) At the State level, the services of one Joint Development Commissioner and the two State Coordinators for women and child programmes working in the Commissionerate for Rural Development are placed at the disposal of State Poverty Eradication Mission.
- 3) At the district level the existing set up of State Poverty Eradication Mission would be strengthened by placing the services of one Assistant Development Commissioner and the Assistant Programme Officer (Women's Welfare) of the Poverty Alleviation Unit, and the District Women Welfare Officer at the disposal of the district unit of the State Poverty Eradication Mission.
- 4) At the level of the Block Panchayat, Extension Officer (Women's Welfare) would report to the district unit of the State Poverty Eradication Mission. The Secretary

of the Block Panchayat would provide necessary assistance as required by the State Poverty Eradication Mission.

- 5) At the Village Panchayat level, one Village Extension Officer would carry out the work related to National Rural Livelihood Mission.

The Joint Development Commissioner and the Assistant Development Commissioners to move to the Mission would be selected through a transparent process from among the existing officers to ensure that the best officers are available for the new Scheme.


