ORDER

As per existing orders, Local Governments have to spend at least 80% of the total available funds in respect of Development Fund and Maintenance Fund failing which the shortfall in expenditure is deducted from future allocation. This mandatory limit has been reduced to 70% for the year 2010-11 as per G.O.read as 3rd paper above. Owing to various reasons including the Code of Conduct prevailed as part of the election to State Legislative Assembly-Piravom by election, took away a considerable period of time needed for the formulation and preparation of plan, selection of beneficiaries, etc. Considering this situation, Government are pleased to reduce the mandatory minimum expenditure to 60% under Development Fund and Maintenance Fund for the year 2011-12.
