**ORDER**

As per the letter read as first paper above Government of India, have required all State Governments to furnish information for the year 2011-12 for the creation of a data base of the finances of the Panchayath Raj Institutions and Urban Local Bodies. The Performance Grant to the three-tier Panchayats and Urban Local Bodies recommended by the 13<sup>th</sup> Finance Commission will not be released unless this information is furnished by the State Governments.

In order to collect information from the three-tier Panchayaths and the Municipalities & Municipal Corporations of Kerala for preparation of the database, the Information Kerala Mission has developed a Software interface published in the website of the LSGD. The Software interface can be accessed through **<http://finance.lsgkerala.gov.in/dbofinance>**.

The Secretaries of all District/Block/Grama Panchayats and Municipalities and Municipal Corporations shall furnish the information online in respect of the Budgets and Annual Financial Statements for the year **2011-12 on or before 30.7.2012**. Instructions for filling in the form are available in the website. If

considered necessary, the sample form and instructions for filling the form can be downloaded, a print-out taken and filled in first, before filling the form online.

The Director of Urban Affairs, The Assistant Development Commissioners (General)/Deputy Directors of Panchayaths shall oversee that the Secretaries of the Municipal Corporations/Municipalities and the Secretaries of the Block/Grama Panchayaths furnish the information online in time. The Director of Urban Affairs, the Commissioner for Rural Development and the Director of Panchayaths will furnish a report in this regard to Government by **31.7.2012.**
