**ORDER**

Kumari. Bincy Annamma Wilson, D/o. Late Mariamma Samuel, who died in harness on 05/03/2011 while working as Head Clerk Panthalam Thekkekkara Gramapanchayat, Pathanamthitta District applied for employment assistance under Compassionate Employment Scheme as per the application read as 2<sup>nd</sup> paper above. The application was submitted within the prescribed time limit. The deceased Government servant put in a total service of 22 years 01 month 24 days.

The applicant is 21 years old as her date of birth being 13.08.1991. She has passed B.A Degree. The request is for the appointment in the post of Lower Division Clerk and she is qualified for that post.

The Director of Panchayats and the District Collector, Kollam as per the letters read as 3<sup>rd</sup> and 4<sup>th</sup> papers above have recommended the request of Kumari. Bincy Annamma Wilson. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements. The applicant is the daughter and a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.



The District Collector, Pathanamthitta as per the letter read as 4<sup>th</sup> paper above has reported that the annual family income of the deceased Government Servant is Rs.1,10,000/- (Rupees One lakh ten thousand only).

In the above circumstances, Government are pleased to appoint Kumari. Bincy Annamma Wilson, D/o. Late Mariamma Samuel, Head Clerk, Panthalam Thekkekkara Gramapanchayat, Pathanamthitta District in the existing/arising vacancy of Lower Division Clerk in Pathanamthitta District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1<sup>st</sup> paper above.

The Director of Panchayats shall issue formal appointment order to Kumari. Bincy Annamma Wilson, in this regard. and shall verify that the conditions stipulated in the GO read as 1<sup>st</sup> paper above are fulfilled.

The Deputy Director of Panchayats, Pathanamthitta shall make necessary entries in the Service Book of the deceased Government employee and in Establishment Register, regarding grant of employment to the dependant of late. late Mariamma Samuel Head Clerk, Panthalam Thekkekkara Grama Panchayat, Pathanamthitta District, as stipulated in the Government Order read as 1<sup>st</sup> paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
