ORDER

In the order read as first and second paper above Permissive Sanction had been given to all Grama Panchayaths, Municipalities and Corporations in Thiruvananthapuram, Kollam, Alapuzha, Kottayam, Ernakulam, Thrissur, Palakkad, Malappuram, Kozhikkode, Kannur and Kasargode district to give financial support to the Health Services department in their Mass Drug Administration Programme as part of the global eradication of Lymphatic Filariasis.

2.The Director of Health Services in the letter read as 3rd paper above has requested to accord permissive sanction to Grama Panchayats, Block Panchayats and Urban Local Bodies in districts except Pathanamthitta, Idukki and Wayan^{du} to give financial support to the concerned CHC/PHC/Hospital for the above programme which is scheduled to be implemented during 12th to 14th March 2013.

Government have examined the proposal in detail and are pleased to accord permissive sanction to all Grama Panchayaths, Municipalities, Corporations in Thiruvananthapuram, Kollam, Alapuzha, Kottayam, Ernakulam, Trissur, Palakkad, Malappuram, Kozhikkode, Kannur and Kasargodu districts to give financial support to the concerned CHC/PHC/Hospital on the decision taken in their Committee/Council for the Mass Drug Administration Programme 2013 at the following rates from their own fund.
