**ORDER**

As per the Judgment dated 3.10.12 in WP(C) No.22856/2012 filed by Sri. Abdul Khader, Illikottil Veedu, Mullurkkara P.O., Thrissur, read as 1<sup>st</sup> paper above, the Hon'ble High Court has directed the 1<sup>st</sup> respondent ie; Government to consider Ext P11 appeal petition submitted by the Petitioner in accordance with law and to pass appropriate orders thereon, as expeditiously as possible and at any rate within a period of two months of the date of receipt of a copy of this Judgment.

2. Exhibit P 11 representation dated 05.9.2012, read as 2<sup>nd</sup> paper above, is the request of the petitioner to direct the Grama Panchayath to issue building number in his building. But the said appeal petition is not seen received in Government. Hence immediately on receipt of the copy of the writ petition, the Government have forwarded the copy of the Exhibit P11 appeal petition to the Deputy Director of Panchayats, Thrissur for his immediate report on this matter.

The Deputy Director of Panchayats has reported that Sri.Abdul Khader constructed a paper bag manufacturing unit in the land marked in the Revenue Records as Paddy land. This construction was against the Kerala Conservation of Paddy and Wet land Act 2008. As per existing rule building number can not be given to the commercial constructions carried out in Paddy Land. However subject to certain conditions number can be given to the residential buildings. But the petitioner's construction is a commercial one. As per the existing rule building number cannot be given to the petitioner's building.

3. Government have examined the matter in detail. Government is not in a position to consider the Exhibit P11 appeal petition as the construction violating the existing rules. Hence the Exhibit P11 appeal petition is rejected in due compliance to the direction contained in the judgment dated 3/10/2012 in WP(C)No.22856/2012.
