### ORDER

Shri. Rajesh. R., S/O. late. Radhakrishnan. P., who died in harness on 08.01.2012 while working as Part Time Ferryman, Alappad Gramapanchayat, Kollam district applied for employment assistance under Compassionate Employment Scheme as per the application read as 3<sup>rd</sup> paper above. The application was submitted within the prescribed time limit. The deceased Government servant put in a total service of 24 years, 2 months and 3 days.

The applicant is 37 years old as his date of birth being 25.05.1975. He has passed the SSLC. The request is for the appointment in the post of Office Attendant and he is qualified for that post.

The Director of Panchayats and the District Collector, Kollam as per their letters read as 4<sup>th</sup> and 5<sup>th</sup> papers above have recommended the request of Shri. Rajesh. R. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements. The applicant is the son and a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Kollam as per the letter read as 5<sup>th</sup> paper above has reported that the annual family income of the deceased Government Servant is Rs.24000/- (Rupees Twenty four thousand only).

As the applicant is married, the Tahasildar, Karunagappally as per the certificate read as 6<sup>th</sup> paper above has certified that Shri. Rajesh. R. was a dependent of his father till his death.

In the above circumstances, Government are pleased to appoint Shri. Rajesh. R., S/O. late. Radhakrishnan. P., Part Time Ferryman, Alappad Gramapanchayat, Kollam district in the existing/arising vacancy of Office Attendant in Kollam District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1<sup>st</sup> and 2<sup>nd</sup> papers above.

The Director of Panchayats shall issue formal appointment order to Shri. Rajesh. R. in this respect and shall verify that the conditions stipulated in the GOs read as 1<sup>st</sup> and 2<sup>nd</sup> papers above are thoroughly fulfilled

The Deputy Director of Panchayats, Kollam shall make necessary entries in the Service Book and Establishment Register regarding the grand of employment to the dependant of late. Sri.Radhakrishnan.P who died in harness on 08.01.2012 as stipulated in the Government Order read as 1<sup>st</sup> paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.


