ORDER

In the letter read above, the Director of Health Services has requested Government to extend the co-operation and financial assistance for the prevention and control activities of communicable diseases in pre-monsoon period of 2013.

Government have examined the proposal in detail and are pleased to accord permissive sanction to all Grama Panchayats, Municipalities and Corporations to give financial support to all Health Sanitation committees under their jurisdiction for utilization for prevention and control activities of communicable disease in the pre-monsoon period of 2013 as per the guidelines for Ward Health Sanitation Committees fund such as for the campaign mode of cleaning and mosquito control activities at the following rates from their own fund subject to the decision taken in their Council / Committees.

Grama Panchayats	₹10,000 (Ten thousand only) maximum per institution
Municipalities	₹15,000(Fifteen thousand only) maximum per institution
Corporations	₹20,000(Twenty thousand only) maximum per institution

The Local Self Government Institution is requested to allot the amount to the concerned CHC / PHC / Hospital in their area. The concerned Superintendent / Medical Officer should give utilization certificate of the fund to the respective Local Self Government Institution.
