ORDER

Smt.N.Suseela. D/o. late. N.Radha., who died in harness on 23.06.2010 while working as Part Time Sweeper, Kongad Grama Panchayat, Palakkad District applied for employment assistance under Compassionate Employment Scheme as per the application read as 3rd paper above. The application was submitted within the prescribed time limit. The deceased Government servant put in a total service of 19 years, 5 months and 5 days.

The applicant is 46 years old as her date of birth being 03.01.1967. She has passed the SSLC. The request is for the appointment in the post of Part time Contingent employee and she is qualified for that post.

The Director of Panchayats and the District Collector, Palakkad as per their letters read as 4th and 5th papers above have recommended the request of Smt. N.Suseela. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements. The applicant is the daughter and a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Palakkad as per the letter read as 5th paper above has reported that the annual family income of the deceased Government Servant is Rs.12000/- (Rupees Twelve Thousand only).

As the applicant is married, the Tahasildar, Palakkad as per the certificate read as 6th paper above has certified that Smt.N.Suseela was a dependent of her mother till her death.

In the above circumstances, Government are pleased to appoint Smt. N.Suseela., D/o. late.N.Radha ., Part Time Sweeper, Kongad Grama Panchayat, Palakkad District in the existing/arising vacancy of Part Time Contingent Employee in Palakkad District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Orders read as 1st and 2nd papers above.

The Director of Panchayats shall issue formal appointment order to Smt.N.Suseela. in this respect and shall verify that the conditions stipulated in the GOs read as 1^{st} and 2^{nd} papers above are thoroughly fulfilled.

The Deputy Director of Panchayats, Palakkad shall make necessary entries in the Service Book and Establishment Register regarding the grand of employment to the dependant of late. Smt.N. Radha who died in harness on 23/06/2010 as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
