#### **ORDER**

Sri.Padmakiran.K, S/o. late. Padmanabhan.K who died in harness on 07/11/2009 while working as Part Time Sweeper, Kottayam Grama Panchayat. Kannur District applied for employment assistance under Compassionate Employment Scheme as per the application read as 2<sup>nd</sup> paper above. The application was submitted within the prescribed time limit. The deceased Government servant put in a total service of 10 years 9 Months and 01 day.

The applicant is 21 years old as his date of birth being 16/05/1992. He has passed Higher Secondary examination. The request is for the appointment in the post of Lower Division Clerk and he is qualified for that post.

The Director of Panchayats and the District Collector, Kannur as per the letters read as 3<sup>rd</sup> and 4<sup>th</sup> papers above have recommended the request of Sri.Padmakiran.K. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements. The applicant is the unmarried son and a real dependent of the deceased. None of the dependants of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Kannur as per the letter read as 4<sup>th</sup> paper above has reported that the annual family income of the deceased Government Servant is Rs.14,400/- (Rupees Fourteen thousand and four hundred only).

In the above circumstances. Government are pleased to appoint Sri Padmakiran K. S/o. late. Padmanabhan K., Part Time Sweeper, Kottayam Grama Panchayat, Kannur District as Lower Division Clerk in the existing/arising vacancy in Kannur District, under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1<sup>st</sup> paper above.

The Director of Panchayats shall issue formal appointment order to Sri.Padmakiran.K in this regard and verify that the conditions stipulated in the GO read as 1<sup>st</sup> paper above are thoroughly fulfilled.

The Deputy Director of Panchayats, Kannur shall make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register, regarding grant of employment to Sri.Padmakiran.K, the dependant of late K.Padmanabhan who died in harness on 07/11/2009 while working as Part Time Sweeper, Kottayam Grama Panchayat, Kannur District as stipulated in the Government Order read as  $\Gamma^{1}$  paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
