ORDER

Smt.Sheefa.K, D/o. late K.Krishnamma, who died in harness on 20/03/2007 while working as Part Time Sweeper, Andoorkonam Grama Panchayat in Thiruvananthapuram district applied for employment assistance under Compassionate Employment Scheme as per the application read as 2nd paper above. The application was submitted within the prescribed time limit. The deceased Government servant put in a total service of 07 years.

The applicant is 50 years old her date of birth being 20/05/1963. She has passed the SSLC. The request is for the appointment in the post of Lower Division Clerk / Last Grade Servant. But the upper age limit of the applicant has been crossed for the appointment in the post of Lower Division Clerk / Last Grade Servant.

The Director of Panchayats and the District Collector, Thiruvananthapuram as per their letters read as 4th and 6th papers above have recommended the request of Smt.Sheefa.K. The applicant is the daughter and a real dependent of the deceased. None of the family members of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Thiruvananthapuram as per the letter read as 6th paper above has reported that the annual family income of the deceased Government servant is Rs.18,000/- (Rupees Eighteen thousand only) and recommended for the post of Part time contingent employee.

The Tahasildar , Thiruvananthapuram as per the letter read as 5^{th} paper above has reported that, the applicant had been depending her mother till the death of the later even after the marriage of the former.

In the above circumstances, Government are pleased to appoint Smt.Sheefa. K, D/o. late K.Krishnamma, Part Time Sweeper, Andoorkonam Grama Panchayat, Thiruvananthapuram District, in the existing/arising vacancy of Part Time sweeper Post in Thiruvananthapuram District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order, read as 1st and 3rd papers above.

The Director of Panchayats shall issue formal appointment order to Smt. Sheefa. K in this respect and shall thoroughly verify that the conditions stipulated in the Government Order read as 1^{st} and 3^{rd} papers above are fulfilled.

The Deputy Director of Panchayats, Thiruvananthapuram shall make necessary entries in Service Book of the deceased government employee and in the Establishment Register regarding grant of employment to Smt. Sheefa.K, the dependant of late K.Krishnamma who died in harness on 20/03/2007 while working as Part Time Sweeper Andoorkonam Grama Panchayat, Thiruvananthapuram District as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.

The seniority of the applicant for the appointment shall be placed as per the condition 1(iii) stipulated in the order read as 3rd paper above.
