As per the letter read as 1st paper above, Government of India have sanctioned the proposal of Kerala under PMGSY-I, Phase VIII amounting to Rs.457.04 Cr. for 320 road works with a total length of 745.9 km. While giving clearance, Government of India among certain other condition stipulated that a competent officer should be selected for the post of Financial Controller on full time basis. The clause 7.4 of the guidelines of PMGSY also stipulates the same.

2) As per the Government Order read as 2nd paper above, state Government have issued Administrative sanction for the scheme. Hence State Government have to comply with the condition stipulated by Government of India.

3) Government have examined the matter in detail and are pleased to accord sanction for the creation of a post of Financial Controller in the

Kerala State Rural Roads Development Agency for PMGSY Projects in the rank of Joint Secretary from Finance Department on deputation basis.
