<u>ORDER</u>

Shri. Vishnu.A, S/o. late A.Kelukutty, Peon, who died in harness on 12/07/2007 while working as Peon, Kunnamangalam Grama Panchayat, in Kozhikode district applied for employment assistance under Compassionate Employment Scheme as per the application read as 2nd paper above. The application was submitted within the prescribed time limit. The deceased Government servant put in a total service of 15 years, 02 months and 13 days.

The applicant is 19 years old as his date of birth being 30/05/1994. He has passed the Higher Secondary Examination. The request is for the appointment in the post of Lower Division Clerk and he is qualified for that post.

The Director of Panchayats and the District Collector, Kozhikkode as per their letters read as 3rd and 4th papers above have recommended the request of Sri.Vishnu.A. The applicant is the son and a real dependent of the deceased. None of the family members of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Kozhikkode as per the letter read as 4th paper above has reported that the annual family income of the deceased Government servant is Rs.72,000/-(Rupees Seventy Two thousand only).

In the above circumstances, Government are pleased to appoint Shri. Vishnu.A, S/o. late A. Kelukutty., Peon, Kunnamangalam Grama Panchayat, Kozhikode District, in the existing/arising vacancy of Lower Division Clerk in Kozhikode District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order, read as 1st paper above.

The Director of Panchayats shall issue formal appointment order to Shri. Vishnu.A in this respect and shall thoroughly verify that the conditions stipulated in the Government Order read as 1st paper above are fulfilled.

The Deputy Director of Panchayats, Kozhikode shall make necessary entries in Service Book of the deceased government employee and in the Establishment Register regarding grant of employment to Sri.Vishnu.A, the dependant of late A. Kelukutty who died in harness on 12/07/2007 while working as Peon, Kunnmangalam Grama Panchayat. Kozhikode District as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
