### ORDER

Miss. Dhrysia Raj.P, D/o. late Janu Kuniyil, Upper Division Clerk, who died in harness on 19/07/2004 while working as Upper Division Clerk, Cheruvannur Grama Panchayat, in Kozhikode District applied for employment assistance under Compassionate Employment Scheme as per the application read as 2<sup>nd</sup> paper above. The application was submitted within the prescribed time limit. The deceased Government servant put in a total service of 17 years, 09 months and 18 days.

The applicant is 19 years old, her date of birth being 27/05/1994. She has passed the Higher Secondary Examination. The request is for the appointment in the post of Lower Division Clerk and she is qualified for that post.

The Director of Panchayats and the District Collector, Kozhikkode as per their letters read as 3<sup>rd</sup> and 4<sup>th</sup> papers above have recommended the request of Miss. Dhrysia Raj.P. The applicant is the daughter and a real dependent of the deceased. None of the family members of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Kozhikkode as per the letter read as 4<sup>th</sup> paper above has reported that the annual family income of the deceased Government servant is Rs.30,000/- (Rupees Thirty thousand only).

In the above circumstances, Government are pleased to appoint Miss. Dhrysia Raj.P. D/o. late Janu Kuniyil., Upper Division Clerk, Cheruvannur Grama Panchayat, Kozhikkode District, in the existing/arising vacancy of Lower Division Clerk in Kozhikkode District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order, read as 1<sup>st</sup> paper above.

The Director of Panchayats shall issue formal appointment order to Miss. Dhrysia Raj.P in this respect and shall thoroughly verify that the conditions stipulated in the Government Order read as 1<sup>st</sup> paper above are fulfilled.

The Deputy Director of Panchayats, Kozhikkode shall make necessary entries in Service Book of the deceased government employee and in the Establishment Register regarding grant of employment to Miss. Dhrysia Raj.P, the dependant of late Janu Kuniyil who died in harness on 19/07/2004 while working as Peon, Kunnamangalam Grama Panchayat, Kozhikkode District as stipulated in the Government Order read as 1<sup>st</sup> paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
