### **ORDER**

Smt. Sobhakumary.G., W/o.Late. S.Ramachandran Nair, who died in harness on 04/04/2007 while working as Lower Division Clerk in Mangalpadi Grama Panchayat, Kasaragod District applied for employment assistance under Compassionate Employment Scheme as per the application read as 3<sup>rd</sup> paper above. Since the application was not submitted within the prescribed time limit, it was rejected vide Government letter read as 5<sup>th</sup> paper above. Later Government have condoned the delay in submitting the application as per the Government Order read as 2<sup>nd</sup> paper above. The deceased Government servant put in a total service of 20 years 9 months and 23 days.

The applicant is 50 years old as her date of birth being 24/05/1963. She has passed S.S.LC Examination. The request is for the appointment in the post of Lower Division Clerk and she is qualified for that post.

The Director of Panchayats and the District Collector, Thiruvananthapuram as per the letters read as 4<sup>th</sup> and 6<sup>th</sup> papers above have recommended the request of Smt.Sobhakumary.G. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements. The applicant is the wife and a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Thiruvananthapuram as per the letter read as 6<sup>th</sup> paper above has reported that the annual family income of the deceased Government Servant is Rs.1,71,600/- (Rupees One lakh Seventy one thousand Six hundred only).

In the above circumstances, Government are pleased to appoint Smt. Sobhakumary.G. W/o. Late. S.Ramachandran Nair, Lower Division Clerk, Mangalpadu Grama Panchayat, Kasaragod District in the existing/arising vacancy of Lower Division Clerk in Thiruvananthapuram District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1<sup>st</sup> paper above.

The Director of Panchayats shall issue formal appointment order to Smt.Sobhakumary.G, in this regard and verify that the conditions stipulated in the GO read as 1<sup>st</sup> paper above are fulfilled.

The Deputy Director of Panchayats, Kasargod shall make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register, regarding grant of employment to the dependant of late. S.Ramachandran Nair, Lower Division Clerk, Mangalpadu Grama Panchayat, Kasaragod District, as stipulated in the Government Order read as 1<sup>st</sup> paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.


