### <u>ORDER</u>

Smt. K. Vilasini., W/o. Late. M.Ramachandran, who died in harness on 04/10/2011 while working as Lower Division Clerk in Vaniyamkulam Grama Panchayat, Palakkad District applied for employment assistance under Compassionate Employment Scheme as per the application read as 2<sup>nd</sup> paper above. The application was submitted within the prescribed time limit. The deceased Government servant put in a total service of 12 years, 07 months and 10 days.

The applicant is 45 years old as her date of birth being 20/01/1969. She has passed S.S.LC Examination. The request is for the appointment in the post of Lower Division Clerk and she is qualified for that post.

The Director of Panchayats and the District Collector, Palakkad as per the letters read as 3<sup>rd</sup> and 4<sup>th</sup> papers above have recommended the request of Smt.K.Vilasini. All the also relinquished their of the deceased heirs have favour of the applicant and have given their consent statements. The applicant is the wife and a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Palakkad as per the letter read as 4<sup>th</sup> paper above has reported that the annual family income of the deceased Government Servant is Rs.1,06,640/-(Rupees One lakh six thousand six hundred forty only).

In the above circumstances, Government are pleased to appoint Smt. K.Vilasini., W/o. Late. M.Ramachandran , Lower Division Clerk, Vaniyamkulam Grama Panchayat, in the existing/arising vacancy of Lower Division Clerk in Palakkad District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1<sup>st</sup> paper above.

The Director of Panchayats will issue formal appointment order to Smt.K.Vilasini, in this regard and verify that the conditions stipulated in the GO read as 1<sup>st</sup> paper above are fulfilled.

The Deputy Director of Panchayats, Palakkad will make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register, regarding grant of employment to the dependant of late, M.Ramachandran, Lower Division Clerk, Vaniyamkulam Grama Panchayat, Palakkad District, as stipulated in the Government Order read as 1<sup>st</sup> paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
