**ORDER**

Smt.Sobha.P.G W/o.Late.T.K.Narayanan, Permanent Laborer, Government Transport & Equipment Organisation, Muvattupuzha residing at Thazhathoottu House, Thrikalathoor.P.O, Muvattupuzha, Ernakulam District as per her application read as 2<sup>nd</sup> paper above has applied for employment assistance under Compassionate Employment Scheme. The matter was enquired through the District Collector, Ernakulam and has recommended the request for employment assistance as per the report read as 3<sup>rd</sup> paper above.

Sri.T.K.Narayanan expired on 03.07.2012, while working as Permanent Laborer, Government Transport & Equipment Organisation, Muvattupuzha Ernakulam District in the Rural Development Department. He had put in a total service of 19 years and 8 months at the time of his death. His wife Smt.Sobha.P.G. has applied for employment assistance under the scheme. All other dependents have relinquished their claim for employment assistance in favour of the applicant.

Smt.Sobha.P.G. has passed S.S.L.C with more than 40% marks.. She is aged 45 years. Her date of birth is 30.04.1968. She has requested for appointment as Village Extension Officer Grade II in the Rural Development Department in Ernakulam District. The District Collector, Ernakulam and the Commissioner for Rural Development have recommended the applicant for appointment under the Scheme as Village Extension Officer Grade II in the Rural Development Department in Ernakulam District. The applicant satisfies all the conditions for being appointed as Village Extension Officer.

In the circumstances reported by the District Collector, Ernakulam and the Commissioner for Rural Development, Thiruvananthapuram in their letters read as 3<sup>rd</sup> and 4<sup>th</sup> papers above and as per the provisions contained in the Government Order read as 1<sup>st</sup> paper above, sanction is accorded for the appointment of Smt.Sobha.P.G W/o.Late.T.K.Narayanan, Permanent Laborer, Government Transport & Equipment Organisation, Muvattupuzha residing at Thazhathoottu House, Thrikalathoor.P.O, Muvattupuzha, Ernakulam District in the existing/arising vacancy of Village Extension Officer Grade II in the Rural Development Department in Ernakulam District subject to the provisions governing the scheme. The Commissioner for Rural Development will issue formal posting orders to the applicant.

Smt.Sobha.P.G will produce a copy of her photograph, recently taken, duly attested by a Gazetted Officer before the Commissioner for Rural Development at the time of joining duty. Before admitting her to duty, the original documents in proof of her age, educational qualification and medical fitness should be verified. Her character and antecedents will also be got verified through the Police Department in due course. If the appointment is in a District other than the District of option for want of vacancy, she will be given transfer to the District of option in the next arising vacancy without loss of seniority. The five year rule prescribed for inter-district transfer of district-wise recruits will be made applicable in this case from the date of posting to the district of her choice. The details of appointment under the scheme will be entered in the Service Book of the deceased Government employee and also in the Establishment Register of the office in which the Government employee last worked and the fact will be attested by Head of office/Head of Department.

The appointment will be cancelled if and when it is found that there was misrepresentation or suppression of material facts at the time of applying for appointment under the Compassionate Employment Scheme or during the course of the enquiry by the departmental authorities.

Government will have the right to cancel the order sanctioning this appointment under the Compassionate Employment Scheme if, after the issue of the order, it is seen on examination that the orders were issued erroneously.
