## **ORDER**

Sri.Shaffaf.P., S/o.late. Abdul Gafoor, who died in harness on 28/02/2005 while working as Head Clerk in Pookottur Grama Panchayat, Malappuram District applied for employment assistance under Compassionate Employment Scheme. The deceased Government servant put in a total service of 16 years 4 months and 22 days.

The applicant is 20 years of old as his date of birth being 23/09/1994. He has passed Plus Two examination. The request is for the appointment in the post of Lower Division Clerk and he is qualified for that post.

The Director of Panchayats and the District Collector, Malappuram as per the letters read as 3<sup>rd</sup> and 4<sup>th</sup> papers above have recommended the request of Sri.Shaffaf.P. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements. The applicant is a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Malappuram as per the letter read as 4<sup>th</sup> paper above has reported that the annual family income of the deceased Government Servant is Rs.3.96.564/- (Rupees Three lakh Ninety six thousand Five hundred and Sixty four only).

In the above circumstances, sanction is accorded to the Deputy Director of Panchayats. Malappuram to appoint Sri.Shaffaf.P. S/o. late. Abdul Gafoor, Head Clerk, Pookottur Grama Panchayat, Malappuram District in the existing/arising vacancy of Lower Division Clerk in Malappuram District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1<sup>st</sup> paper above after verifying all the original certificates.

The Deputy Director of Panchayats, Malappuram would make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register. regarding grant of employment to the dependant as stipulated in the Government Order read as 1<sup>st</sup> paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
