ORDER

As per the Government Order read as first paper above, Shri.S.D.Pillai,IA&AS,Senior Deputy Accountant General was appointed as State Performance Audit Officer on deputation basis for a period of two years from 01/10/2007. Subsequently, Government had extended his period of deputation upto 30/11/2013, as per the Government Orders read as second paper to sixth paper above. Consequent to his retirement from Central service (IA&AS) on 30.11.2013, as per Government Order read as 7th paper above, Government have temporarily permitted him to continue in the post of State Performance Audit Officer till a new SPAO is posted.

- (2) As the State Performance Audit Officer, Shri.S. Divakaran Pillai, has contributed his vast professional expertise in the area of management of accounting and audit system of Panchayat Raj Institutions. His charismatic leadership and innovative endeavour in this field helped Government of Kerala to accelerate the decentralisation process. Moreover, he is the repository of the organisational memory in the department.
- (3) Considering the excellent service that Shri. S.D.Pillai has rendered during his period of deputation as State Performance Audit Officer and the invevitable requirement of his continued service in the Local Self Government Department, Government have examined the matter in detail and are pleased to re-appoint Shri. S.Divakaran Pillai IA&AS (retired) as State Performance Audit Officer from 01.12.2013 with retrospective effect under rule 36, KS&SSRS for a period of one year or till a new State Performance Audit Officer is posted on deputation basis.

(4) .His pay and allowances will be fixed as per rule 100 Part III Kerala Service Rul He is permitted to enjoy all special powers and privilleges which was sanctioned to him on I promotion as Accountant General prior to his retirement.
