Sri.Manoj.G. B/o.late. Binoj.G, who died in harness on 02/01/2002 while working as Field Assistant in District Serifed Office in Wayanad District applied for employment assistance under Compassionate Employment Scheme. The deceased Government servant put in a total service of 6 years..

The applicant is 42 years of old as his date of birth being 09/11/1971. He has passed SSLC examination. The request is for the appointment in the post of Lower Division Clerk and he is qualified for that post.

The Managing Director, Serifed and the District Collector, Wayanad as per the letters read as 5th and 6th papers above have recommended the request of Sri. G. Manoj. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements. The applicant is a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Wayanad as per the letter read as 6th paper above has reported that the annual family income of the deceased Government Servant is Rs.1,40,000/- (Rupees One lakh Forty thousand only).

In the above circumstances, sanction is accorded to the Deputy Director of Panchayats, Wayanad to appoint Sri.Manoj.G. B/o. late. G.Binoj. The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
