ORDER

Smt. Shibina.K.Rasheed D/o.late. S.Rasheeda, who died in harness on 11/02 2009
while working as Upper Division Clerk in Koruthode Grama Panchayat, Kottayam District
applied for employment assistance under Compassionate Employment Scheme. The
deceased Government servant put in a total service of 16 years 10 months and 23 days.

The applicant is 20 years old as her date of birth being 11/06/1994. She has passed
SSLC & +2 examinations. The request is for the appointment in the post of Lower Division
Clerk in Kottayam District and she is qualified for that post.

The Director of Panchayats and the District Collector, Kottayam as per the letters
read as 3rd and 4th papers above have recommended the request of Smt. Shibina.K.Rasheed.
All the legal heirs of the deceased have also relinquished their claims in favour of the
applicant and have given their consent statements. The applicant is a real dependent of the
deceased. None of the dependents of the deceased has applied for availing the benefit under
the scheme earlier. No other family members of the applicant have got appointment under
the Scheme.

The District Collector, Kottayam as per the letter read as 4th paper above has
reported that the annual family income of the deceased Government Servant is
Rs.1,07,664/- (Rupees One lakh Seven thousand Six hundred and Sixty four only).

In the above circumstances, sanction is accorded to the Deputy Director of
Panchayats, Kottayam District to appoint Smt. Shibina.K.Rasheed, D/o.late. S.Rasheeda,
Upper Division Clerk, Koruthode Grama Panchayat, Kottayam District in the existing
arising vacancy of Lower Division Clerk in Kottayam District under Compassionate
Employment Scheme subject to the conditions laid down in the Government Order read as
1st paper above after verifying all original certificates.

The Deputy Director of Panchayats, Kottayam shall make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register, regarding grant of employment to the dependant as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
