Sri.Thomas Chandy, M.L.A representing Kuttanadu Constituency as per his letter read as 2<sup>nd</sup> paper above proposed to take up the following seven road works under LAC-ADS for the year 2013-14 at a total estimate cost of **Rs.215,00,000/- (Rupees Two Hundred and Fifteen Lac only)**.


