ORDER

Smt.Rabia, M/o.late. Rijas.J, who died in harness on 25/05/2010 while working as Lower Division Clerk in Muttill Grama Panchayat, Wayanad District applied for employment assistance under Compassionate Employment Scheme. The deceased Government servant put in a total service of 10 months and 11 days.

The applicant is 55 years old as her date of birth being 14/05/1959. She has passed Vth Standard. The request is for the appointment in the post of Part Time Sweeper in Wayanad District and she is qualified for that post.

The Director of Panchayats and the District Collector, Wayanad as per the letters read as 3rd and 4th papers above have recommended the request of Smt. Rabia. The applicant is a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Wayanad as per the letter read as 4th paper above has reported that the annual family income of the deceased Government Servant is Rs.12,000/- (Rupees Twelve thousand only).

In the above circumstances, sanction is accorded to the Director of Panchayats, to appoint Smt.Rabia, M/o.late. Rijas.J, Lower Division Clerk, Muttill Grama Panchayat, Wayanad District in the existing/arising vacancy of Part Time Sweeper in Panchayat Department in Wayanad District under Compassionate Employment Scheme subject to the conditions laid down in the Government Order read as 1st paper above after verifying all original certificates.

The Deputy Director of Panchayats, Wayanad shall make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register, regarding grant of employment to the dependant as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
