<u>ORDER</u>

Sri.U.Sreekumar, S/o.late Lunnikrishnan Nair, who died in harness on 01/08/2012 while working as Full Time Sweeper in Kattappana Grama Panchayat, Idukki District applied for employment assistance under Compassionate Employment Scheme. The deceased Government servant put in a total service of 16 years and 29 days.

The applicant is 27 years old as his date of birth being 01/08/1987. He has passed +2 Examination. The request is for the appointment in the post of Lower Division Clerk and he is qualified for that post.

The Director of Panchayats and the District Collector, Idukki as per the letters read as 3rd and 4th papers above have recommended the request of Sri.U.Sreekumar. The deceased Government servant have no other legal heirs except Sri.U Sreekumar. The applicant is a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Idukki as per the letter read as 4th paper above has reported that the annual family income of the deceased Government Servant is Rs.24,000/- (Rupees Twenty four thousand only).

In the above circumstances, sanction is accorded to the Deputy Director of Panchayats, Idukki to appoint Sri.U.Sreekumar S/o.Late & Unnikrishnan Nair, Full Time Sweeper, Kattappana Grama Panchayat, Idukki District in the existing/arising vacancy of Lower Division Clerk in Idukki District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1st paper above after verifying all original certificates.

The Deputy Director of Panchayats, Idukki shall make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register, regarding grant of employment to the dependant as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
