ORDER

Smt.Ciji Varghese, D/o. late. M.P.Varghese, who died in harness on 11/08/2011 while working as Part Time Ferryman in Poothrikka Grama Panchayat, Ernakulam District applied for employment assistance under Compassionate Employment Scheme as per the application read as 2nd paper above. The application was submitted within the prescribed time limit. The deceased Government servant put in a total service of 20 years, 08 months and 11 days.

The applicant is 37 years old as her date of birth being 31/05/1977. She has passed SSLC & Pre Degree examinations. The request is for the appointment to the post of Lower Division Clerk and she is qualified for that post.

The Director of Panchayats and the District Collector, Ernakulam as per the letters read as 3rd and 4th papers above have recommended the request of Smt.Ciji Varghese. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements. The applicant is the daughter and a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Ernakulam as per the letter read as 4th paper above has reported that the annual family income of the deceased Government Servant is Rs.24,000/-(Rupees Twenty four thousand only).

In the above circumstances, Government are pleased to appoint Smt.Ciji Varghese., D/o. late. M.P.Varghese, Part Time Ferryman, Poothrikka Grama Panchayat, in the existing/arising vacancy of Lower Division Clerk in Ernakulam District under Compassionate Employment Scheme, in Panchayat Department subject to the conditions laid down in the Government Order read as 1st paper above.

The Director of Panchayats will issue formal appointment order to Smt.Ciji Varghese, in this regard and verify that the conditions stipulated in the GO read as 1st paper above are thoroughly fulfilled.

The Deputy Director of Panchayats, Ernakulam will make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register, regarding grant of employment to the dependant of late, M.P.Varghese, Part Time Ferryman, Poothrikka Grama Panchayat, Ernakulam District, as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
