**ORDER**

Smt.Krishnammal.A, W/o.late. Rajan.A.N, who died in harness on 18/06/2012 while working as Lower Division Clerk in Mangalpady Grama Panchayat ,Kasargode District applied for employment assistance under Compassionate Employment Scheme. The deceased Government servant put in a total service of 2 years 11 months and 25 days.

The applicant is 41 years old as her date of birth being 12/03/1973. She has passed standard 10<sup>th</sup> equivalency Examination. The request is for the appointment in the post of Office Attendant and she is qualified for that post.

The Director of Panchayats and the District Collector, Kasargode as per the letters read as 3<sup>rd</sup> and 4<sup>th</sup> papers above have recommended the request of Smt.Krishnammal.A. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements. The applicant is a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Kasargode as per the letter read as 4<sup>th</sup> paper above has reported that the annual family income of the deceased Government Servant is Rs.50,169/- (Rupees Fifty thousand One hundred and sixty nine only).

In the above circumstances, sanction is accorded to the Deputy Director of Panchayats, Kasargode to appoint Smt.Krishnammal.A, W/o. late. Rajan.A.N, Lower Division Clerk, Mangalpady Grama Panchayat, Kasargode District in the existing/arising vacancy of Office Attendant in Kasargode District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1<sup>st</sup> paper above after verifying all the original certificates.

The Deputy Director of Panchayats, Kasargode shall make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register, regarding grant of employment to the dependent as stipulated in the Government Order read as 1<sup>st</sup> paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
