ORDER

As proposed by Smt.Geetha Gopi, M.L.A representing Nattika Constituency as per the reference read as 2nd paper above, the Chief Engineer, PWD, Roads & Bridges furnished detailed estimate for the work 'Providing CC drain at km 0/350 of Velumampadi-Kunjalakkal-Chettakkulam Road' in Chazhour Grama Panchayat at an estimate cost of Rs.25,00,000/-(Rupees Twenty Five Lac only) under LAC-ADS as per the reference read as 3rd paper above for according Administrative Sanction and Special Sanction.


