Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work 'Construction of Nehru Park in Kottayam Municipality phase II' at an estimate cost of Rs. 71.87 lakhs (Rupees Seventy one Lakhs Eighty seven Thousand only) proposed under the LAC-ADS of Shri. Thiruvanchoor Radhakrishnan, Minister for Forest, Environment, Transport, Sports & Cinema representing Kottayam LAC with Special Sanction to take up the work for execution following all departmental formalities and in tune with the guidelines as per the GO read as 3rd paper above.
