ORDER

SmtVijayakumari.R., W/o.late. K.V.Jayachandran Pillai who died in harness on 27/10/2012 while working as Lower Division Clerk in Palamel Grama Panchayat Alapuzha District applied for employment assistance under Compassionate Employment Scheme. The deceased Government servant put in a total service of 15 years and 29 days.

The applicant is 35 years old as her date of birth being 18/5/1979. She has passed SSLC Examination. The request is for the appointment in the post of Lower Division Clerk and she is qualified for that post.

The Director of Panchayats and the District Collector, Alapuzha as per the letters read as 3rd and 4th papers above have recommended the request of Smt.Vijayakumari.R. The applicant has given consent on behalf of the minor children of the deceased. The applicant is a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Alapuzha as per the letter read as 4th paper above has reported that the annual family income of the deceased Government Servant is Rs.8400/-- (Rupees Eight Thousand and Four Hundred only).

In the above circumstances, sanction is accorded to the Deputy Director of Panchayats, Alapuzha to appoint Smt.Vijayakumari.R, W/o. late. K.V.Jayachandran Pillai, Lower Division Clerk, Palamel Grama Panchayat, Alapuzha District in the existing/arising vacancy of Lower Division Clerk in Alapuzha District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1st paper above after verifying all the original certificates.

The Deputy Director of Panchayats, Alapuzha shall make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register, regarding grant of employment to the dependent as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
