ORDER

Sri.C.R.Venu,S/o late. Meenalochini Ammal, who died in harness on 05/03/1996 while working as Assistant, in Lower Primary School at Kakkanad in Ernakulam District applied for employment assistance under Compassionate Employment Scheme vide applications read as 4th papers above. As he has not passed SSLC, the Grama Panchayat could not appoint him in the same school according to his qualifications. Hence he has filed a writ petition before the Hon'ble High Court seeking appointment under Compassionate Employment Scheme in the MAMLPS,Thrikkakkara. The Hon'ble High Court vide judgment dated 19/11/2009 has directed Government to consider Ext.P4 and ExtP11 and to pass appropriate orders.

The deceased Government servant put in a total service of 22 years 01 month and 25 days.The applicant is 36 years old as his date of birth being 11/05/1978. He has not passed S.S.L.C Examination. The request is for the appointment to the post of Office Attendant and he is qualified for that post.

The Director of Panchayats vide letter read as 5TH paper above and the District Collector, Ernakulam as per the letters read as 6th papers above have recommended the request of Sri.C.R.Venu. All the legal heirs of the deceased have relinquished their claims in favour of the applicant and have given their consent statements. The applicant is a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Ernakulam as per the letter dated, 2/7/2014 read as 6th paper above has reported that the annual family income of the deceased Government Servant is Rs.34,000/- (Rupees Thirty Four thousand only).

Government have examined the matter in detail and are pleased to accord sanction as a special case to the Deputy Director of Panchayats, Ernakulam to appoint Sri,C.R.Venu, S/o late Meenalochini Ammal, L.P. School Assistant, Thrikkakara Grama Panchayat, Ernakulam District in the existing/arising vacancy of Office Attendant in the Panchayat Department Ernakulam District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1st paper above after verifying all the original certificates.

The Deputy Director of Panchayats, Ernakulam shall make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register, regarding grant of employment to the dependent as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
