ORDER

Smt. Meena.P W/o.late. Jayakrishnan.C, who died in harness on 30/08/2012 while working as Part Time Sweeper, Wandoor Grama Panchayat, Malappuram District applied for employment assistance under Compassionate Employment Scheme. The deceased Government servant put in a total service of 05 years 08 months and 24 days.

The applicant is 43 years old as her date of birth being 105/05/1972. She has passed SSC Examination. The request is for the appointment in the post of Lower Division Clerk in Malappuram District and she is qualified for that post.

The Director of Panchayats and the District Collector, Malappuram as per the letters read as 3rd and 4th papers above have recommended the request of Smt. Meena.P. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements. The applicant is a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Malappuram as per the letter read as 4th paper above has reported that the annual family income of the deceased Government Servant is Rs.60,372/- (Rupees Sixty thousand three thousand and seventy two only).

In the above circumstances, sanction is accorded to the Deputy Director of Panchayats, Malappuram to appoint Smt. Meena.P W/o.late. Jayakrishnan.C., Part Time Sweeper, Wandoor Grama Panchayat, Malappuram District in the existing/arising vacancy of Lower Division Clerk in Malappuram District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1st paper above after verifying all the original certificates.

The Deputy Director of Panchayats, Malappuram shall make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register, regarding grant of employment to the dependent as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
