ORDER

As proposed by Sri.I.C.Balakrishnan, MLA representing Sulthan Bathery Constituency under LAC-ADS for the year 2014-15 as per the reference read as 2nd paper above, the Chief Engineer, PWD, Buildings, Thiruvananthapuram has furnished detailed estimate of the work 'Construction of Heritage Museum at Kalloor in Noolpuzha Grama Panchayat' at an estimate cost of Rs.25,00,000/- (Rupees Twenty Five Lac only) as per the reference read as 3rd paper above to accord Administrative Sanction and Special Sanction.
