As proposed by **Dr.N.Jayaraj, MLA representing Kanjirappally Constituency** under LAC-ADS for the year 2014-15 as per the reference read as 2nd paper above, the Chief Engineer, PWD(R&B) has furnished detailed estimate of the work '**Improvements to 20th Mile – Nellimoodu Road from Ch 0/000 to 1/600 Km in Chirakkadavu Grama Panchayat**' at an estimate cost of **Rs.25,00,000/- (Rupees Twenty Five Lac only)** as per the reference read as 4th paper above to accord Administrative Sanction and Special Sanction. Chirakkadavu Grama Panchayat furnished resolution in this regard as per the reference read as 3rd paper above.


