## <u>ORDER</u>

As proposed by Sri.N.Sakthan, Speaker, Kerala Legislative Assembly and MLA representing Kattakkada Constituency, Kerala Small Industries Development Corporation(SIDCO) furnished detailed estimate of the work 'Installation of 47 LED High Mast Lights in 6 Grama Panchayats' in Kattakkada Constituency at an estimate cost of Rs.5 Lac each with a total estimate cost of Rs.2,35,00,000/- (Rupees Two Hundred and Thirty Five Lac only) as per the reference read as 2<sup>nd</sup> paper above to accord Administrative Sanction and Special Sanction. The respective Local Bodies furnished resolutions in this regard.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work 'Installation of 47 LED High Mast Lights in 6 Grama Panchayats' in Kattakkada Constituency proposed under LAC-ADS of Sri.N.Sakthan, Speaker, Kerala Legislative Assembly and MLA representing Kattakkada Constituency for the year 2015-16 at a total estimate cost of Rs.2,35,00,000/- (Rupees Two Hundred and Thirty Five Lac only) with Special Sanction to take up the work for execution following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1st paper

above and subsequent Government orders subject to the condition that the work should be executed as deposit work by SIDCO, Thiruvananthapuram.
