ORDER

Smt. Treesa.T. George D/o.late. P.Georgekutty, who died in harness on 04/08/2012 while working as Full time Sweeper, Eraviperoor Grama Panchayat, Pathanamthitta District, applied for employment assistance under Compassionate Employment Scheme. The deceased Government servant put in a total service of 18 years 02 months and 04 days.

The applicant is 25 years old as her date of birth being 25/05/1990. She has passed SSLC examination. The request is for appointment in the post of Lower Division Clerk in Pathanamthitta District and she is qualified for that post.

The Director of Panchayats and the District Collector, Pathanamthitta as per the letters read as 3rd and 4th papers above have recommended the request of Smt. Treesa.T. George. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements . The applicant is a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Pathanamthitta as per the letter read as 4th paper above has reported that the annual family income of the deceased government servant is Rs.24,000/- (Rupees Twenty four thousand only).

In the above circumstances, sanction is accorded to the Deputy Director of Panchayats, Pathanamthitta to appoint Smt. Treesa.T. George D/o.late.P. Georgekutty, Full time Sweeper, Eraviperoor Grama Panchayat, Pathanamthitta District in the existing/arising vacancy of Lower Division Clerk in Pathanamthitta District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1st paper above after verifying all the original certificates.

The Deputy Director of Panchayats, Pathanamthitta shall make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register regarding grant of employment to the dependent as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.


